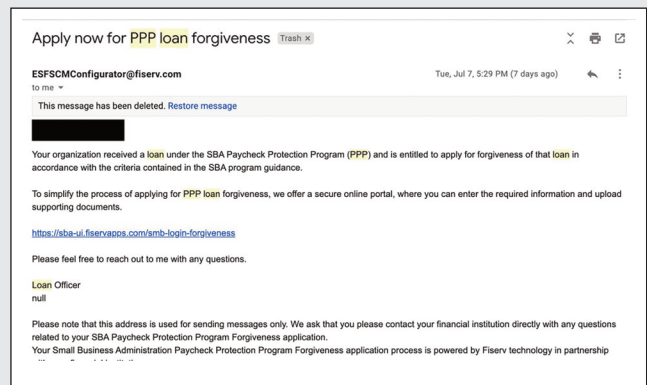
Now accepting applications for forgiveness!

Logging into the forgiveness application portal is as easy as 1-2-3:

STEP 1

You will receive a customized email with the subject line "Apply now for PPP loan forgiveness" from @fiserv.com. You will simply click on the link within the email to begin your application.

NOTE: You will need to use Google Chrome™ as your web browser. If you don't have Google Chrome, you can download it here.



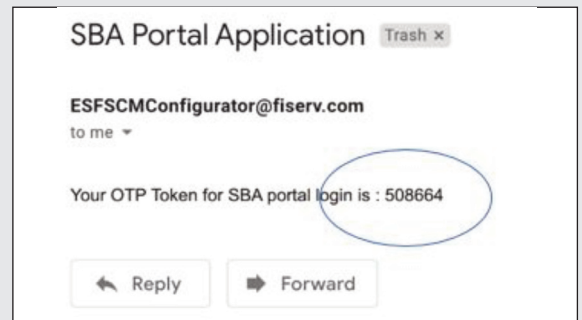
STEP 2

Once you arrive at the portal, you will enter your business name **exactly as it is listed** in the previously received email with the Employer Identification Number, or EIN (no hyphenation). If you filed as an individual, you will need to enter your full name **as it appears in the email** along with your Social Security number (no hyphenation).

A one-time passcode (OTP) will be generated and sent to your email. You will use this OTP to log into the portal.

- Once you are in the forgiveness portal, you will need to upload your supporting loan forgiveness documents using the list below; see 3508S instructions (pg 3) for required documentation.

Consider the following example, when choosing which documentation to upload to the portal.

Example: For many borrowers, 24 weeks of cash compensation may exhaust all of their PPP loan funds.

In this case, a borrower may not need to substantiate any other eligible costs.
